

## **Bravecto® Quantum (fluralaner for extended-release injectable suspension) 365 Days of Adventure Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Each winner may be required to execute prize acceptance documents within the time frame required by Sponsor (defined below), as more fully detailed below.

By entering this Sweepstakes (defined below), you agree to these Official Rules, which are a contract, so read them carefully before entering. Without limitation, this contract includes indemnities to Sponsor and Armstrong (defined below) from you, a limitation of your rights and remedies, and a waiver of your right to bring or participate in class-action claims. This contract also includes a license from you permitting Sponsor and other parties broad rights to re-use any content you submit as part of your entry and the grant of a right to use your name/likeness in association with re-use of that content, including publication in Sponsor's marketing materials.

**1.
