

Merck Animal Health Veterinary Student Giveaway

NO PURCHASE IS NECESSARY TO PARTICIPATE OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The Merck Animal Health Veterinary Student Giveaway (the "Giveaway") is open only to those who complete the Veterinary Student Monthly Quiz and who are eighteen (18) years of age as of the date of entry. The Giveaway is only open to legal residents of one of the 50 United States or the District of Columbia and is void where prohibited by law.
